- **1. Apologies for absence** Cllr Dorothy Sutcliffe.
- 2. Declarations of interest in matters on the agenda none were declared.
- 3. Minutes of meeting of WayaHead Group held on 17 January agreed.
- 4. Matters arising: as on the agenda.
- 5. Parish Plan Priorities for 2011
  - **5.1. Blackshaw Head Play Area** The project was still looking for funding. Funds raised at the Blackshaw Head BBQ on 29 April would go towards the Play Area. It was also suggested that funding should be sought from Play England.
  - **5.2. The Penn Village Green Application** Calderdale Council have arranged for a public enquiry on either 4/5 or 10/11 May and appointed a barrister to preside and make a recommendation to the Council.
  - **5.3. Charlestown Community Garden/Allotments –** The Parish council have made a formal request for the land between the Woodman Inn and Ingle Dene previously owned by the Parish Council to be transferred back from Calderdale Council for use as allotments and a community garden. The proposal was discussed and it was agreed to proceed.
  - **5.4. Great Rock –** Similarly the Parish Council have also made a formal request for the land at Great Rock previously owned by the Parish Council to be transferred back from Calderdale Council for use as public open space. The proposal was discussed and it was agreed to proceed.
  - 5.5. Blackshaw Broadband Community Initiative It was reported that a group of local residents were working on a grant application to Yorkshire Forward to improve Broadband availability to the Blackshaw Community.
  - **5.6. Dog fouling Poster Competition -** The proposal involving both local schools was discussed.
  - **5.7. Improving Ingle Dean exit road –** The severe danger of the exit from behind Ingle Dene and the lack of a Safe Route to School was discussed. It was agreed to arrange a meeting with the Road Safety Unit
  - **5.8. Other issues** The new Hebden Bridge campsite at the New Delight is being launched on 2 April at 12 noon to 3pm.
